

## Call for Artists

The Ashtabula County Suicide Prevention Coalition and the Ashtabula County LOSS Team, in collaboration with the Ashtabula Arts Center, are seeking artwork submissions for our fifth annual show, **Hope in Artistry: Reducing Stigma and Raising Awareness for Suicide Prevention**. A variety of mediums will be accepted, including photography, painting, illustrations and mixed media. This is a great opportunity for artists in Ashtabula County and Northeast Ohio to show your work, support survivors of suicide, reduce stigma, and raise awareness to help prevent suicide. In 2020, Ashtabula County lost 17 individuals to suicide. That puts us well over both the state and national suicide rates. Suicide is one of the leading causes of death across all demographic categories of Ashtabula County residents. We know that friends and loved ones who are left behind after a suicide loss are placed at a greatly elevated risk of dying by suicide themselves and are in need of awareness, intervention, and support. **Hope in Artistry: Reducing Stigma and Raising Awareness for Suicide Prevention** offers an artistic outlet for survivors and community artists to show support for survivors, raise awareness, and start conversations about suicide loss and prevention.

Description of Event: A juried exhibit of artwork to **reduce stigma, raise awareness for suicide prevention, and commemorate National Survivors of Suicide Day (November 20, 2021)**. Both two and three-dimensional work is eligible. Open to all artists who reside in Ashtabula County (artwork from residents outside of Ashtabula County will be considered on a case by case basis). All artists and the public are invited to view the artwork during regular business hours at the Ashtabula Arts Center during the month of November. Artists and the public are invited to a reception on Thursday, November 18, 2021, 6-8pm at the Ashtabula Arts Center to celebrate the artwork and honor survivors of suicide loss.

To Apply:

1. Complete Entry Form and waiver.
2. Submit Artwork to Ashtabula Arts Center on October 29, 2021 (9am-4pm) & October 30, 2021 (9am-1pm). Artists will be notified of their acceptance by October 31, 2021 by 5 pm via the Ashtabula Arts Center website ([www.ashtabulaartscenter.org](http://www.ashtabulaartscenter.org)). If accepted, artwork will be displayed at the Ashtabula Arts Center during the month of November, with pick-up on November 30 & December 1, 2021. Artwork that has not been accepted must be picked up no later than November 4, 2021 (anytime during operating hours). Artists are responsible for the delivery, pack, and transport of their artwork, and must provide for the return of their submitted artwork at their own risk and expense. Art Exhibit Release and Waiver of Liability Form

Artist grants permission for exhibit organizers to reproduce Artist's name, information describing the submitted artwork, and any other information Artist has provided for the purpose of displaying the submitted artwork, and for the promotion and publicity of the exhibit. **All sales of artwork during the show will be brokered through the Ashtabula Arts Center. The Ashtabula Arts Center applies a 30% commission for any sales generated from the show.**

Artist agrees to deliver, pack, transport, and provide for the return of their submitted artwork at their own risk and expense. Artists may deliver artwork to the Ashtabula Arts Center on October 29, 2021 (9am-4pm) & October 30, 2021 (9am-1pm). Artists will be notified of their acceptance by October 31, 2021, by 5:00 pm. If accepted, artwork will be displayed at the Ashtabula Arts Center during the month of November. Artwork that is not accepted for showing can be picked up no later than November 4, 2021 (during operating hours). Artwork accepted for the show may be picked-up November 30 & December 1, 2021, at the Ashtabula Arts Center (during operating hours). Works left over 30 days become the property of the Ashtabula Arts Center.

**Release of Liability: Ashtabula County Suicide Prevention Coalition and Ashtabula County Mental Health Recovery Services Board, and their employees, agents, representatives, personnel, and members, shall not be liable for any injury to artists or for any damage or loss of Artists' works, equipment, or other personal property arising out of the art exhibition, the mounting and/or other activities involved in the preparation and/or presentation of the art exhibition. Artists shall indemnify, save, and hold harmless the Ashtabula County Suicide Prevention Coalition and Ashtabula County Mental Health Recovery Services Board, and their employees, agents, representatives and members, from any and all claims, demands, causes of action and judgments, losses, costs, and expenses, including but not limited to reasonable attorney's fees, arising from or in any way related to the use of Artists' works, equipment, or other personal property, including but not limited to any representation, warranty, term and/or condition of this agreement.**

**Artist understands that the area where artwork is to be displayed will be in a building open to public, during day and evening hours of operation, and has limited supervision. With this understanding, Artists release the Ashtabula County Suicide Prevention Coalition and Ashtabula County Mental Health Recovery Services Board, and their employees, agents, representatives, personnel, and members, from any liability for loss, theft, or damage to any piece of artwork the Artists submit.**
